1. The Company's Annual Report for the financial year 2025 including the ratification of the Company's Financial Statements for the financial year 2025 and the Supervisory Report of the Board of Commissioners of the Company for the financial year ending 31 December 2025.
 2. Determination of the use of the Company's net profit for the financial 2025;
 3. Appointment of a Public Accounting Firm to audit the Company's Financial Statements of 2026 and other requirements regarding the appointment.
 4. Determination of salary or honorarium, bonuses and allowances for members of the Board of Commissioners as well as salary or honorarium, bonuses and allowances for members of the Company's Board of Directors.
 5. Guarantee approval of more than 50% (fifty percent) of the Company's net worth in order to obtain a bank loan facility.
 6. Approval of the change in Company data resulting from the change of Controlling Shareholder, from Prinsep Management Ltd to PT Prinsep Indo HLD.

- C. The meeting was attended by 3.131.959.700 shares, who have valid voting rights or equivalent to approximately 89,87% of the total number of shares with valid voting rights that have been issued by the Company.
- D. In the Meeting, the opportunity is given to ask questions and/or provide opinions regarding the entire Agenda of the Meeting.
- E. There were no questions and/or opinions submitted by the shareholders or their proxies in all Meeting Agendas.
- F. The decision-making mechanism in the Meeting is as follows: Meeting decisions are taken by way of deliberation and consensus. If deliberation to reach consensus is not reached, then a vote is held.
- G. Results of decision making for the 1st (First), 2nd (Second), 3 (Third), 4 (Fourth), 5 (fifth). 6 (sixth)
- H. In essence, the Meeting Resolutions are as follows:

First Meeting Agenda :

Accepting the Board of Directors' Report regarding the Company's operations including the Board of Commissioners' Supervisory Duty Report for the Financial Year 2025. With the receipt of the Board of Directors' Report regarding the Company's operations and the Board of Commissioners' supervisory task report for the 2025 financial year, it also means giving full release and settlement (*Acquit et de charge*) to the Board of Directors and the Board of Commissioners of the Company for their management and supervisory actions during the 2025 financial year, as long as these actions are not criminal acts and are reflected in the Statement of Financial Position and the Company's Income Statement.

Second Meeting Agenda :

Distributing cash dividends of 21.76% (twenty one point seven six percent) of the net profit for the 2025 Financial Year or Rp. 243,949,286,000,- (two hundred forty three billion nine hundred forty nine million two hundred eighty six thousand Rupiah) or Rp. 70,- (seventy Rupiah) per share shall be distributed to the Shareholders, subject to and in accordance with applicable laws and regulations.

Third Meeting Agenda :

Delegating authority to the Company's Board of Commissioners by taking into account the recommendations of the Audit Committee to select and appoint a Registered Public Accountant to audit the Company's books for the 2026 financial year, including appointing a replacement Public Accounting Firm and/or Public Accountant in the event that the appointed Public Accounting Firm and/or Public Accountant for any reason whatsoever is unable to perform or complete its work, and granting authority to the Company's Board of Directors to determine the honorarium and other requirements for such appointment appointed Public Accountant for any reason cannot perform or complete his work, with the criteria set by the Company or complete its work, and granting authority to the Company's Board of Directors to determine the honorarium and other requirements for such appointment.

Fourth Meeting Agenda :

1. Approved to authorize representatives of the Company's Shareholders, to PT Prinsep Indo HLD as the Company's shareholder with share ownership of 79.31% of all issued shares of the Company to determine the amount of honorarium bonuses and allowances in 2026 for all members of the Company's Board of Commissioners.
2. Approved to authorize the Company's Board of Commissioners to determine the amount of salary, bonuses and allowances in 2026 for all members of the Company's Board of Directors.

Fifth Meeting Agenda :

Approved the guarantee of more than 50% (fifty percent) of the Company's net worth in order to obtain a bank loan facility.

Sixth Meeting Agenda :

1. To approve granting authority to the representative of the Company's shareholder—namely PT Prinsep Indo HLD, holding a 79.31% stake in the Company's total issued shares—to determine the amount of honoraria, bonuses, and allowances for the year 2026 for all members of the Company's Board of Commissioners.
2. Granting power of attorney with the right of substitution to the Company's Directors to state the decisions of this GMS in a Notarial Deed and to appear before a Notary or authorized official, and to make adjustments or improvements as necessary if required by the authorized party for the purposes of implementing the contents of the meeting's decisions.
